

SAME Meeting, 01 Sep 2021

Talking Points

1. Hurricane Ida Response:

- MVD is the lead Division
- All contracting actions should come from MVD
- SWD is currently providing support personnel for ESF3 under FEMA tasking (debris removal teams, blue roofs, ice, water)

2. Fort Polk:

- No significant damage from Hurricane Ida
- District Commander is at Fort Polk and Barksdale AFB today
- Current Hurricane Laura damage repair projects – roofs – awarded
- Schedule issues with VOLAR renovations – contract holders are using the same mechanical and electrical subs

3. End of Fiscal Year:

- Most actions that have been in the SRM, Civil Works O&M and CESU realms. SRM has gone to JOC contracts for the most part
- Actions without a MATOC or JOC are in the solicitation or evaluation phase
- Just a handful of sole source may remain

- #### 4. Border Infrastructure – limited work on-going in RGV (restore levee protection, safety); most in suspension still

5. IDCs / MATOCS:

a. Military Vertical Construction MATOC

- **Small Business** – source selection, award w/seed project 30 Sep 21 - \$640M
- **8(a)** – solicitation amendment issued 24 Aug, closes 24 Sep 2021 (award 5 Apr 2022) - \$164M
- **WOSB** – Final SCO review on-going followed by compliance review and solicitation issue on 12 Sep 21 (award 26 Apr 22) - \$116M
- **HUBZone** – In district preparing for final SCO review, issue solicitation 10 Sep 21 (award 12 Apr 22) - \$115M
- **SDVOSB** – finalizing compilation of the solicitation package, internal review and then SCO, issue solicitation 14 Oct 21 (award 27 May 22) - \$102M
- **Unrestricted** – BCOES review, issue solicitation 6 Feb 22, award 5 Dec 22 - \$2.36B

b. AE Services COS and Energy

- Issue solicitation 22 Sep 21 (likely to slip 1-2 weeks), award 18 Jul 22 - \$81M

c. AE Services

- **Military Programs** – Final SCO review this week, issue solicitation 16 Sep 21, award 1 Sep 22 (3 groups to negotiate – one large business, two small business) - \$245M
- **Civil Works** – final in-house review, then SCO; solicit to Small Businesses 25 Sep 21, award 16 May 22 - \$105M
- **CPS** – In-house compliance review on-going, completing the CSE memo, to SCO 17 Sep 21, solicitation issue 8 Oct 21 and award 23 Sep 22 (3 groups to negotiate – one large business, two small business) - \$200M

d. **ECSO**

- **ECSO AE Vertical Design** – Prep synopsis for SCO review, solicitate 18 Sep 21 (DHS – vertical design) and any day for DLA (facility assessments, BUILDER), award 27 Jul 22 (DHS) and 29 Jun 22 (DLA) - \$125M
- **ECSO Vertical Construction** – delayed, need seed projects (Unrestricted, SB, 8(a), HubZone), awards begin March 2023 – Unrestricted - \$1.5B, Small Business - \$300M, 8(a) - \$150M, HubZone - \$150M
